

Senator Yaw Legislation Signed into Law

By Gov. Rendell

- SB 297 of 2009 Oil and Gas Act – Requiring for natural gas well reporting;
- SB 298 of 2009 Farmland and Forest Land Assessment Act – Amends the Clean and Green law with regard to preferential tax assessment of land for agricultural use and roll-back taxes;
- *PHARE Law (worked with Legislature to help craft the law)

By Gov. Corbett

- SB 723 of 2011 - Designating the Market Street Bridge as the Carl E. Stotz Memorial Little League Bridge;
- SB 1174 of 2012 - Philadelphia Housing Authority Board Restructuring Law;
- SB 259 of 2013 Oil and Gas Lease - Providing for payment information to interest owners of leases regarding natural gas and oil;
- *SB 379 of 2013 Benevolent Gesture Legislation – worked in consultation with Sen. Pat Vance, prime sponsor of the legislation, to move the bill to the Governor’s desk;
- *Act 13 Law (worked with Legislature to help craft the law)

By Gov. Wolf

- SB 1202 of 2015 - Continuing Medical Education Requirements for Medical Professionals;
- SB 215 of 2016 - Creating the Pipeline Investment Program (PIPE) / amended into the Fiscal Code;
- SB 1202 of 2016 - Requires continuing education in pain management, addiction and dispensing for prescribers and dispensers;
- SB 1367 of 2016 - Limiting opioids to minors;
- SB 446 of 2017 - Setting Standards for Drug and Alcohol Recovery Houses (co-prime sponsor with Sen. McGarrigle);
- SB 728 of 2017 - Exempting Schedule V epilepsy drugs currently included in the PDMP requirements;
- SB 679 of 2018 - Increasing Access to Consumer Fireworks / amended into the Tax Code;
- SB 9 of 2019 - Designating the Eastern Hellbender as State Amphibian;

- SB 634 of 2019 – Creating Conservation Excellence Grants as part of the PA Farm Bill;
- SB 694 of 2019 - Reducing Surface Impacts from Unconventional Gas Wells;
- SB 420 of 2021 (Act 88) - Requires a district attorney to hold an active law license while in office and establishes procedures for when a district attorney is disbarred and another if their law license is suspended.
- SB 251 of 2022 (Act 83) – Repeals and makes updates to Pennsylvania’s Fertilizer Law.
- SB 832 of 2022 – Establishing a Clean Streams Fund for Pennsylvania / included as part of the 2022-23 State Budget.
- SB 465 of 2022 – Establishing an Agricultural Conservation Assistance Program / included as part of the 2022-23 State Budget.
